BLOCK PARTY APPLICATION – PAGE 2

The attached application must be completed and filed with the Office of the Township Clerk at least one (1) month prior to the folding of said block party.

If all persons on the block have not signed off on the closing of the street, allow two months for Council approval of said block party.

1. Your street must be closed to vehicular traffic from its intersection with your adjoining intersecting streets.
2. This closing applies to residents vehicles as well as other vehicles. A sign is to be posted at each intersection stating that the roadway is closed to other than residents of the street.
3. You are responsible for making provisions to have the roadway blocked and making sure that there is access for residents to enter and depart as they desire. Portable devices are to be utilized, i.e. wooden horses, garbage pails.

CARS MAY NOT BE USED TO BLOCK OFF ANY STREETS

4. A 12 foot clearance must be maintained on each side of the fire hydrant.
5. Amusement games/rides must be set up on the OPPOSITE side of the street having the fire hydrant.
6. All amusement games/rides must be flush against the curb.
7. Those having entertainment/rides/amusements must be in compliance with state standards. Applicants should obtain a copy of their vendor state certification.
8. There must be an approved traffic lane available at all times for emergency vehicles.
9. No alcoholic beverages are to be consumed on the public thoroughfare.
10. No grills or food tables are to be places in the street.
11. Fire Official approval is required prior to Council approval (if applicable) for all block parties. This approval will be requested by the Township Clerk's office upon filing of the application.
12. The party must end and the streets re-opened to traffic and completely cleared of people, paraphernalia and debris by 10:00p.m.

13. In accordance with the Township Noise Ordinance “No person shall cause, suffer, allow or permit sound producing systems – operating, playing or permitting the operation or playing of any radio, television, phonograph or similar device that reproduces or amplifies sound in such a manner as to create a noise disturbance for any other person other than the operator of the device.
14. Any violation of the provisions of this permit will result in the cessation of the block party as well as the possible issuance of a summons for violation of township ordinances and Title 39.
15. Granting permission by the Township Council to hold said event is in no way an acceptance of liability on the part of the Township for any injuries or damage to persons or property that might occur as a result of the block party and the sponsors of the party must assume full responsibility for same.
